The Lock-In Kick-In GOAL worst-of style is a product that provides a fixed coupon and an additional potential protection feature. The redemption is linked to the performance of the worst performing Underlying.

As long as either a Lock-In Event has occurred or the Kick-In Level has never been touched or breached during the lifetime of the product, the Investor will receive 100% of the Nominal in cash. Otherwise, the Investor will receive

- 100% of the Nominal in cash, if at Expiry all Underlyings close at or above the respective Strike Level; or
- a value reflecting the performance of the worst performing Underlying, if at Expiry one or more Underlyings close below the Strike Level.
