Redemption

The Investor is entitled to receive from the Issuer on the Redemption Date an amount in the Settlement Currency, according to the following scenarios:

The Lookback PERLES Plus is a product that allows investors to fully participate in the performance of the underlying from the lowest price level observed during the Lookback Period. This lookback feature ceases to exist if the Underlying trades at or below the Kick-Out Level during the Kick-Out Observation Period. This means that the Investor will receive a redemption value which reflects the performance of the Underlying plus the difference between the Strike Level and the lowest daily closing level of the Underlying during the Lookback Period, if the Underlying never touches or breaches the Kick-Out Level during the Kick-Out Observation Period.
