As long as the Knock-Out Barrier has not been touched, the Investor will receive the difference between the Strike and the Settlement Price, adjusted for the Conversion Ratio, converted into the Redemption Currency, if applicable.

If the Knock-Out Barrier is touched at any time during the life, the Turbo Put Warrant expires immediately and worthless.

2. Prospects of Profits and Losses

Market Expectation Investors expect the Underlying to decrease in value over the life of the Product and accordingly expect to benefit from a leveraged performance relative to the Underlying.
