Redemption

Product Structure

With a Capped PERLES Plus the investor can participate in the performance of the Underlying up to a defined Cap Level while at the same time benefiting from a conditional downside protection as long as the Expiration Value of the Underlying is at or above the Kick-Out Level at Expiry. Otherwise, the Investor will receive the Underlying, taking into account the Conversion Ratio, if at Expiry the Underlying closes below the Kick-Out Level.

The downside risk of a Capped PERLES Plus is similar to that of the Underlying, i.e. the investor could lose his total investment if the Underlying value falls to zero. The maximum redemption value is limited at the Cap Level.
