## Product Structure

The Turbo Call Warrant is a product that offers the Investor a yield potential that is disproportionately higher than with a direct investment in the corresponding Underlying.

As long as the Knock-Out Barrier has not been touched, the Investor will receive the difference between the Settlement Price and the Strike, adjusted for the Conversion Ratio, converted into the Redemption Currency, if applicable.

If the Knock-Out Barrier is touched at any time during the life, the Turbo Call Warrant expires immediately and worthless.
