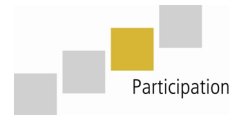

Redemption

Product Structure

The PERLES Plus is a product that provides participation in the performance of the Underlying. This means that the Investor will receive a redemption value which reflects the performance of the Underlying, whereby this redemption value will not be lower than the Strike Level, if the Underlying never touches or breaches the Kick-Out Level during the life of the product.
