Redemption

Product Structure

The Kick-In GOAL with Early Redemption Feature is a product that provides a fixed coupon and the redemption is linked to the performance of the Underlying.

As long as no Kick-In Event or an Early Redemption Event has occurred, the Investor will receive 100% of the Nominal in cash. Otherwise, the Investor will receive

- 100% of the Nominal in cash, if at expiration the Underlying closes at or above the Strike Level; or
- a value reflecting the performance of the Underlying, if at expiration the Underlying closes below the Strike Level.

The Coupon will be paid out in any scenario. The Product offers a relatively high coupon in return for not profiting from gains above the Strike Level and for taking the risk of a loss potential equivalent to a direct investment in the Underlying.

In addition to a standard Kick-In GOAL, this Kick-In GOAL contains an early redemption feature: If the closing price of the Underlying is on any Observation Date at or above the Early Redemption Level, this Kick-In GOAL will early redeem at 100% of the Nominal in cash.
