## Product Structure

The Turbo Put Warrant is a product that allows Investors to profit from the downward movement of the Underlying. They must be aware that the price of the instrument will move disproportionately more than the price of the Underlying.

As long as the Knock-Out Barrier has not been touched, the Investor will receive the difference between the Strike and the Settlement Price, adjusted for the Conversion Ratio, converted into the Redemption Currency, if applicable.

If the Knock-Out Barrier is touched at any time during the life, the Turbo Put Warrant expires immediately and worthless.

The Product offers the potential for high return but at the same time bears the risk of a total immediate loss.
