## Redemption

The Investor is entitled to receive from the Issuer either a delivery of the Underlying or an amount in the Settlement Currency, according to the following scenarios:

## Product Structure

The GOAL worst-of style with Early Redemption is a product that provides a fixed coupon and the redemption is linked to the performance of the worst performing Underlying.

As long as no Early Redemption Event has occurred and all Underlyings close at or above the Strike Level, the Investor will in any event receive 100% of the Nominal in cash. Otherwise, the Investor will receive the worst performing Underlying taking into account the Conversion Ratio.

The Coupon will be paid out in any scenario. The Product offers a relatively high coupon in return for not profiting from a potential positive performance of the Underlyings and for taking the risk of a loss potential equivalent to a direct investment in the worst performing Underlying.

In addition to a standard Worst-of GOAL, this Worst-of GOAL contains an early redemption feature: If the closing prices of all Underlyings are on any Observation Date at or above the Early Redemption Level, this Worst-of GOAL will early redeem at 100% of the Nominal in cash.
