## Product Structure

The GOAL with Early Redemption Feature is a product that provides a fixed coupon and the redemption is linked to the performance of the Underlying.

As long as no Early Redemption Event has occurred and the Underlying closes at or above the Strike Level, the Investor will in any event receive 100% of the Nominal in cash. Otherwise, the Investor will receive a cash amount reflecting the performance of the Underlying, if the Expiration Price of the Underlying is below the Strike Level. In such a case, the redemption amount is linked to the negative performance of the Underlying. The Coupon will be paid out in any scenario.

In addition to a standard GOAL, this GOAL contains an early redemption feature: If the closing price of the Underlying is on an Early Redemption Observation Date at or above the Early Redemption Level, this GOAL will early redeem at 100% of the Nominal in cash.
