Redemption

Product Structure

The Kick-In GOAL worst-of style with Early Redemption is a product that provides a fixed coupon and the redemption is linked to the performance of the worst performing Underlying.

As long as no Early Redemption Event has occurred and the Expiration Value of none of the Underlyings is at or below the respective Kick-In Level at Expiry, the Investor will in any event receive 100% of the Nominal in cash. Otherwise, the Investor will receive

- 100% of the Nominal in cash, if at Expiry all Underlyings close at or above the respective Kick-In Level; or
- a value reflecting the performance of the worst performing Underlying, if at Expiry one or more Underlyings close below the Kick-In Level.

The Coupon will be paid out in any scenario. The Product offers a relatively high coupon in return for not profiting from gains above the Kick-In level and for taking the risk of a loss potential equivalent to a direct investment in the worst performing Underlying.
