If the Underlying does not trade at or above the Barrier Level at maturity, the investor receives 95.65% of the Nominal and participates in the positive Underlying performance up to the Barrier Level. If the Underlying trades at or above the Barrier Level at maturity, the investor receives at Redemption 95.65% of the Nominal plus the Rebate. The minimum repayment at maturity will be the Capital Protection.
