Redemption

The Investor is entitled to receive from the Issuer either a delivery of the Underlying or an amount in the Settlement Currency, according to the following scenarios:

Scenario 2	If NO Early Redemption Event has occurred the investor will receive: 1) If the Expiration Value of all Underlyings is at or above the respective Strike Level, the Investor will receive 100% of the Nominal in cash. 2) If the Expiration Value of one or more Underlyings is below the Strike Level, the Investor will receive the Underlying on the Redemption Date with the worst performance since the Pricing Date, taking into account the relevant Conversion Ratio. The sum of all fractional entitlements to the Underlying, per Nominal, will be paid in cash, based on the Expiration Value. The coupon payment is due in any case.

Product Structure

The GOAL worst-of style with Early Redemption is a product that provides a fixed coupon and the redemption is linked to the performance of the worst performing Underlying.

As long as no Early Redemption Event has occurred and all Underlyings close at or above the Strike Level, the Investor will in any event receive 100% of the Nominal in cash. Otherwise, the Investor will receive the worst performing Underlying taking into account the Conversion Ratio .

The Coupon will be paid out in any scenario. The Product offers a relatively high coupon in return for not profiting from a potential positive performance of the Underlyings and for taking the risk of a loss potential equivalent to a direct investment in the worst performing Underlying.

In addition to a standard Worst-of GOAL, this Worst-of GOAL contains an early redemption feature: If the closing prices of all Underlyings are on any Observation Date at or above the Early Redemption Level, this Worst-of GOAL will early redeem at 100% of the Nominal in cash.
