With a Speeder the investor can participate in the leveraged upside performance of the Underlying basket up to a defined Cap Level.

If the Underlying Basket closes below the Strike Level at Expiry, Investors will receive an amount equivalent to the Expiration Value on the Redemption Date.

The downside risk of a Speeder is similar to that of the Underlying Basket, i.e. the investor could lose his total investment if the Underlying Basket value falls to zero. The maximum redemption value is limited at the Cap Level.
