The Mini-Future Long moves approximately 1 unit of currency up, if the Underlying moves 1 unit of currency up and vice versa taking into account the conversion ratio and the adjustments of the Financing Level.

If the value of the Underlying at any time during the product life time lies at or below the Current Stop Loss Level, the Mini-Future Long expires immediately and is redeemed at market price. The Investor shall be aware that the occurrence of a Stop Loss Event will be determined in the sole discretion of the Calculation Agent.
