## Product Structure

A Mini-Future Short allows investors to profit from the downward (bearish) trend of an Underlying. The Mini-Future Short moves approximately 1 unit of currency up, if the Underlying moves 1 unit of currency down and vice versa taking into account the conversion ratio, the adjustments of the Financing Level and, as the case may be, the FX Exchange rate. The risk of loss is limited to the invested capital.

If the value of the Underlying at any time during the product life time lies at or above the Current Stop Loss Level, the Mini-Future Short expires immediately and is redeemed at market price.
