## Product Structure

The Open End Turbo Put Warrant allows investors to profit from the downward (bearish) trend of an Underlying. The Open End Turbo Put Warrant moves approximately 1 unit of currency up, if the Underlying moves 1 unit of currency down and vice versa taking into account the conversion ratio and the adjustments of the Strike / Knock-Out Barrier. If the value of the Underlying at any time during the product life time lies at or above the Current Knock-Out Barrier, the Open End Turbo Put Warrant expires immediately and worthless.

The Investor shall be aware that the occurrence of a Knock-Out Event will be determined in the sole discretion of the Calculation Agent. The risk of loss is limited to the invested capital.

The Current Knock-Out Barrier is always equal to the Current Strike.
