## Redemption

## Product Structure

The Kick-In GOAL is a product that provides a fixed coupon and the redemption is linked to the performance of the Underlying. As long as no Kick-In Event has occurred, the Investor will in any event receive 100% of the Nominal in cash. Otherwise, the Investor will receive

- 100% of the Nominal in cash, if at expiration the Underlying closes at or above the Strike Level; or
- a value reflecting the performance of the Underlying, if at expiration the Underlying closes below the Strike Level.

The Coupon will be paid out in any scenario. The Product offers a relatively high coupon in return for not profiting from gains above the strike level and for taking the risk of a loss potential equivalent to a direct investment in the Underlying.
