Long Factor Certificates allow investors to participate disproportionately (with constant leverage) in the positive development of the Underlying. Conversely, investors also participate disproportionately (with constant leverage) in the negative development of the Underlying. Investors bear the risk of the Long Factor Certificates expiring worthless if the value of the Underlying at any time during the product life time lies at or below the Current Strike (a so-called Knock Out Event has occurred).

Long Factor Certificates also contain a Reset Event mechanism which ensures that intraday movements in the value of the Underlying above the Current Strike but at or below the Current Reset Barrier result in downward adjustments of the Current Strike and the Conversion Ratio that are aimed at limiting the investors risk of loss (but do not prevent partial or total loss of the capital invested). The risk of loss is limited to the invested capital.

Monitoring Period

The Monitoring Period means the period from one adjustment of the Current Strike, Conversion Ratio and Current Reset Barrier to the next succeeding adjustment on each Adjustment Date and coming into effect at the Adjustment Time or, in case a Reset Event occurred, immediately after the occurrence of such Reset Event.

Reset Event

A Reset Event shall be deemed to occur if at any time during the Monitoring Period the price of the Underlying quoted by the Relevant Exchange is **at or below the Current Reset Barrier but above the Current Strike**, as reasonably determined by the Calculation Agent. For the avoidance of doubt, the last available Current Reset Barrier before any adjustments is made due to the occurrence of a Reset Event, is relevant for the determination if a Reset Event has occurred.

Knock Out Event

A Knock Out Event shall be deemed to occur if at any time during the current Monitoring Period, the price of the Underlying as quoted by the Relevant Exchange is **at or below** the Current Strike, as reasonably determined by the Calculation Agent.

A Knock-Out Event will override both the Issuer Call Right and the Investor Exercise Right.
