Stop Loss Level of SILVER (XAG/USD) touched on 12 May 2022.

The Mini Future Long allows investors to profit disproportionately from the upward (bullish) trend of an Underlying. The Mini Future Long moves approximately 1 unit of currency up, if the Underlying moves 1 unit of currency up and vice versa, taking into account the conversion ratio and the adjustments of the Financing / Stop Loss Level.

If the value of the Underlying at any time during the product life time lies at or below the Current Stop Loss Level, the Mini Future Long expires immediately and is redeemed at market price. The risk of loss is limited to the invested capital.
