The Issuer Call will become effective as of close of business on the relevant Valuation Date. In case that any of the dates is not an Exchange Business Day, the next following

Exchange Business Day applies.

The Mini Future will be redeemed on the Maturity Date.

In addition to the possibility to sell the Mini Future in the Secondary Market, each Investor

has the right to exercise the Mini Future every 3 months, for the first time on 01 June 2021 ("Investors Notice Date") for a value equal to the Redemption Amount (as described

herein), effective on the Investors Notice Date (Valuation Date).

The notice has to be received no later than 10:00h, local time Zurich on the relevant Investors Notice Date, otherwise the notice will be effective as per the next following Investor Notice Date. The Investor Exercise will become effective as of close of business on the relevant Valuation Date. In case that any of the dates is not an Exchange Business Day,

the next following Exchange Business Day applies.
